Policy Statement

We will regularly assess and update this policy and associated processes and procedures, to ensure its alignment with the latest FSC standards and best practices in responsible forest management.

Responsibilities

- Board of Directors

The Board of Directors are responsible for overseeing the implementation of this FSC policy and ensuring that it is integrated into each company strategic planning.

- QEMS and Compliance Manager

The QEMS and Compliance Managers is the appointed person responsible for managing and coordinating the association's efforts to comply with the FSC standards and for reporting on progress to the Board of Directors.

Stakeholders


